- **House Bill Creates Billions for Early Childhood Education** Wednesday, October 14, 2009 (*Brian Washington*) The U.S. House of Representatives has voted to approve the Student Aid and Fiscal Responsibility Act (SAFRA), which makes a landmark investment in higher education to ensure that college loans are more affordable for families and more students graduate. But SAFRA also would invest \$1 billion each year—over the next eight years—to build what lawmakers call "comprehensive, high quality, early learning systems" for children from birth to age five, a notion supported by NEA. In an interview with The Associated Press, Education Secretary Arne Duncan reminded states that the goal of education stimulus funding is to make gains in student achievement. "We're going to invest in those states that aren't just talking the talk but that are walking the walk," Duncan said. "If folks are doing this to chase money, it's for the wrong reasons." Many states are changing their laws to compete for about \$5 billion in Race to the Top education grants.

- **Safety Net:** The proposed amendment to section 100.5 of the Regulations of the Commissioner of Education will extend the existing Regents Competency Test (RCT) Safety Net for an additional year to make it available to all eligible students with disabilities entering grade 9 prior to the 2011-12 school year. The proposed amendment will be discussed at the October 19-20, 2009 Board of Regents meeting. Public comment must be received by November 16, 2009.
